(Do not send mail with a signature requirement.) Inspections may be canceled if there are not enough entries.

Early Entry Discounted Inspection Fee: \$205 (must be postmarked at least 6 weeks prior to the inspection date)\*

Regular Inspection Fee: \$225 (must be postmarked at least 5 weeks prior to the inspection date)\*

Late Entry Inspection Fee: \$275 (must be postmarked at least 3 weeks prior to the inspection date)\*

\*ALL PAPERWORK & PAYMENT must be complete & submitted by these deadlines for these prices to apply.

Inspection Entries CLOSE 3 weeks prior to the inspection date. Entries postmarked after this deadline may be accepted at the discretion of the FSA and the inspection organizer for an additional \$100 late fee.

If an inspection fills, entries will be accepted on a first come first serve basis.
