Inspections may be canceled if there are not enough entries.

Early Entry Discounted Inspection Fee: \$90.00 (must be postmarked at least 6 weeks prior to the inspection date)*

Regular Inspection Fee: \$110 (must be postmarked at least 4 weeks prior to the inspection date)*

Late Entry Inspection Fee: \$150 (must be postmarked at least 2 weeks prior to the inspection date)*

*ALL PAPERWORK must be completed and submitted by these deadlines to be eligible for these prices.

Inspection Entries CLOSE 2 weeks prior to the inspection date. Entries may be accepted after the closing date at the discretion of the FSA and the inspection organizer for an additional \$50 late fee.

If an inspection fills, entries will be accepted on a first come first serve basis.
